Pur Natur Holzprodukte – Who we are and what we are doing

Being formed in Wood engineering, three years abroad and an engagement as CEO in a great sawmill, Ruthard Männle dared to go into business for himself in 1988. After long-standing experience in the lamination sector as well as several consulting activities of lumber mills, he turned his focus on the Douglas fir.

Today, we are processing approximately 12.000 m³ to high-quality sawn timber. Also, 10.000m³ commodities are resold again to saw mills and timber trading companies. The catchments area applies from Basel (Switzerland) to Kassel and Vosges Mountains in France to Bavaria.

In this region, we buy selected Douglas fir logs especially butt logs up to 15-m length. Our saw-wood range: Rifts (Quarter sawn timber) up to 150mm width, Quarter balks up to 250 x 250mm and construction timber up to 450 x 450mm and 12m length as well as boles from 30 up to 75mm. Flexibility in lengths depending on the requests of our clients is one of our products' strengths.

Trading and processing acacia and chestnut to top-quality products in gardening and landscaping, construction of playground areas, as well as piles and fencing is another business part of our company; in addition to our beautiful Weymouth - Pine and selected Oak butt logs.

In our own production facility in D-77972 Mahlberg-Orschweier, next to highway no. 5 near Freiburg, we decree about 130 m³ kiln-drying capacities up to max. 9m length and diverse profiling possibilities up to 160 x 200 mm. A perfect example is our high-quality terrace planks.
